**Table Fee** Tables- 1 Table \$135.00, 2 Tables for \$185.00, 3 tables for \$235.00 2 chairs per table and vendor badges will be provided. Tables are to be staffed during the entire show. Dealers will be responsible for their property at all times. The sales room will be closed and security measures will be in effect with the room is closed to the public. It is suggested that a cover be placed over the merchandise during closed hours. We reserve the right to fill the tables based on the room resources like electricity and traffic flow or other criteria at our discretion. PLEASE submit your contracts in advance with the desired number of tables so we are able to create the floor plan and order any tables needed.

**Electricity** — Please advised us as soon as possible if electricity will be needed for your table. You must provide any extra lighting, heavy extension cords, connectors and electrical tape. Dealer agrees to use only cords, fixtures and other electrical apparatus that are UL approved. Should a fire occur through Dealers use of defective wiring, Dealer shall be responsible for any resulting damage.

**Set-up/Takedown** — Friday night set-up hours 11:00am to 6:00pm, Saturday from 7:00am to 9:00am and must be ready by show time at 9:00am. Vendors will have from 3:00pm to 6:00pm after show for takedown. Vendors are asked to not remove or pack any merchandise until the posted show end time unless special circumstance warrant. Please see Leslie if the need arises. AREA MUST BE KEPT CLEAN.

**Parking** – A large parking area is available with extra street parking. Parking is FREE
