Terms and Conditions

Table Fee Tables- 1 Table \$160.00, each additional table is \$65.00

Tables are to be staffed during the entire show. Dealers will be responsible for their property at all times. The sales room will be closed and security measures will be in effect with the room is closed to the public. It is suggested that a cover be placed over the merchandise during closed hours. We reserve the right to fill the tables based on the room resources like electricity and traffic flow or other criteria at our discretion. PLEASE submit your contracts in advance with the desired number of tables so we are able to create the floor plan and order any tables needed. No more than 2 persons may work behind any one table. Only 2 name tags will be issued to each dealer unless otherwise granted. 2 chairs per table will be provided.

Electricity – Please advised us as soon as possible if electricity will be needed for your table. You must provide any extra lighting, heavy extension cords, connectors and electrical tape. Dealer agrees to use only cords, fixtures and other electrical apparatus that are UL approved. Should a fire occur through Dealers use of defective wiring, Dealer shall be responsible for any resulting damage.

Set-up/Takedown – Friday night set-up hours 11:00am to 6:00pm, Saturday from 7:00am to 9:00am and must be ready by show time at 9:00am. Vendors will have from 3:00pm to 6:00pm after show for takedown. Vendors are asked to not remove or pack any merchandise until the posted show end time unless special circumstance warrant. Please see Leslie if the need arises. AREA MUST BE KEPT CLEAN.

Parking – A large parking area is available with extra street parking. Parking is FREE

Publicity - Publicity may include images or video published on internet, local radio, TV, newspaper and all major miniature magazines.

Food - Food may be purchased on the premises. Complimentary coffee, pastries and/or muffins will be served during set up Saturday morning. Meal tickets can be purchased ahead of time.

Cancellations – Cancellations must me made 90 days prior show to receive a full refund, less a \$20.00 cancellation fee. Cancellations after that date will be refunded only if the table is filled by a replacement dealer. There will be no credit for cancellations. Space is reserved upon receipt of signed contract and payment.

By signing this contract I/we agree to abide by all the terms of this contract and the following:

If the show is cancelled by Miniatures in the Wine Country, The show sponsors shall not be responsible to any dealer for damages, loss, or injury. Sponsor reserves the right to terminate any contract at any time for conduct not in the best interest or full support of this show. Vendor expressly agrees to assume all risks of loss or damage to themselves or their property, employees and agents and will not hold Miniatures in the Wine Country Miniature Show, the Lodi Grape Festival and its employees, officers, members, directors and managers responsible for any loss or injury.
